## 1. Profile

---

Paola Arrigoni is research fellow (since January 2020) at Università di Torino, Dipartimento Culture, politica, società (DCPS), Centro ricerca e documentazione fondazioni e società civile.

On 21/10/2019 she has obtained a double PhD in “Social and political change” at the University of Turin and in “Political Science” at the University of Lyon 2. Before this she has had a long career in the private sector of research as Director of research in policies analysis and evaluation, electoral behaviour survey, image and communication studies for institutions, enterprise, association or single political or business actor.

During her career in the private research sector, she was connected to the academic milieu and in this context she wrote some articles and a book on sociological and public policies issues.

In 2016 she decided to follow her scientific interest and she obtained a scholarship for a PhD at the University of Turin in social and political change; followed by a co-tutorship with Science Po at the University of Lyon 2. Her doctoral thesis: “Exploring an interstitial space: Italian FOBs (Fondazioni di Origine Bancaria) as an observatory on elites (1990-2018)” explores changing in power configuration, focusing on elites and philanthropy.

She is nominated “Cultore della Materia” (Subject Expert and Teaching Assistant) in “Political science” by Torino University since 2020.

She is a member of: the multidisciplinary research group “Sui generis –Laboratory for Sociology of Public Action”; the Foundational economy collective; the Laboratory “Triangle, Action, discourses, economic and political thought”, a pluri-disciplinary joint research unit of CNRS, ENS de Lyon (rattachement principal), Université de Lyon2, IEP de Lyon, Université Jean Monnet Saint-Etienne.

Research interests and activities focus on four main domains: novel perspectives on studying elites; civil society elites and political change; organized philanthropy and policymaking; green transition and regional divides.

Beside that her previous experience in the private field of the research also regards public opinion analysis, public policy analysis and electoral behaviour (Ispo Institute, Milan).
