## HEREBY DECREES AS FOLLOWS

### ART. 1 - CALL FOR APPLICATIONS

As provided for by the Regulations on procedures to award scholarships to promising graduates to continue their education issued by Rector's Decree no.1/2018 of 10 January 2018 which lays down to award scholarships aimed at carrying out study activities within the framework of funded research projects, a selection procedure based on qualifications and interview is announced to award no.1 scholarship(s) of the duration of 6 months, which may be renewed, for the scientific-disciplinary field in Historical, Philosophical, Pedagogical and Psychological Sciences to weigh upon funds made available by Fondi Overheads (Spese Generali) del progetto "PRONIA - Personalised Prognostic Tools for Early Psychosis Management" 7PQCP\_CSA16PBRAM\_PRONIA -.

### ART. 2 - ADMISSION REQUIREMENTS

Applicants shall meet the following requirements to be admitted to participate in the selection:

- a) absence of criminal record or of ongoing criminal proceedings;
- b) Master's Degree in Psychology (L.M.-51) or similar academic qualification earned abroad and deemed as equivalent to the corresponding Italian qualification by the relevant academic authorities;
- c) English language proficiency;
- d) be no older than 30 and having earned their qualification, as provided for by the call, for no more than



three years at the deadline to submit applications.

The following requirements and expertise shall be evaluated:

- Previous experience in administering neurocognitive tests and psychological questionnaires;
- Basic knowledge of statistical techniques;
- Proficiency in using Word and Excel files:

Applicants must be in possession of the aforementioned qualifications at the deadline to submit applications.

Applicants in possession of qualifications earned abroad which are not deemed as equivalent shall attach to their application a translation of their foreign qualification (i.e., degree statement reporting their marks for each exam) into Italian or English together with a self-declaration stating that such translation is compliant with the original document. The Judging Committee may decide to admit such qualification for evaluation for the sole purpose of the present selection.

The following qualifications are deemed as valid for the purposes of the present selection procedure:

- scientific curriculum and any other qualification - including a written explanation of the degree dissertation/thesis - or similar documentation useful to prove the relevance of such qualification in relation to the educational activity proposed.

## ART. 3 - APPLICATION

Applications shall be sent via email by certified email address (PEC) or, if in default, by ordinary email (PEO) to email address [unimi@postecert.it](mailto:unimi@postecert.it) by at 11:59 p.m. on the 03.14.2024 (Italian time). It is highly recommended not to exceed 30 Megabytes.

The application form and all other attachments requiring original signature shall be deemed valid only if sent by the applicant to the aforementioned University PEC email address. The email subject line shall be the following: "Pec Application for participation in promising scholarship Prof. Paolo Brambilla Cod. ID 3775."

Unsigned applications, incomplete applications or applications sent after the set deadline shall be rejected.

The following documents must be attached to the application:

- SELF-DECLARATION OR COPY OF THE DEGREE CERTIFICATE REPORTING THE MARKS TAKEN FOR EACH EXAM;
- SCIENTIFIC CURRICULUM INCLUDING QUALIFICATIONS, DIPLOMAS, SCHOLARSHIPS, POST-GRADUATE COURSE COMPLETION STATEMENTS, AND PUBLICATIONS WHICH THE APPLICANT WISHES TO BE EVALUATED.

The aforementioned documentation may be submitted in the following way:

Academic and professional qualifications may be self-certified (*Annex no. 1*). All other qualifications to be evaluated, including publications, may be also submitted as a photocopy together with the self-declaration in lieu of affidavit under art. 46 and 47 of Presidential Decree No.445/2000 (*Annex no.2*).

## ART. 4. - ACTIVITY TO BE PERFORMED

By the present scholarship the winning applicant is required to perform study and research activities at the Department of Dipartimento di Fisiopatologia Medico-Chirurgica e dei Trapianti of the University of Milan and under the supervision of Prof. Paolo Brambilla within the training and research programme named "Artificial intelligence for preventing behavioral problems in subjects at risk for mental health: a digitally informed personalized medicine approach (INTEL)".



## **ART. 5. - SCHOLARSHIP LEGAL STATUS AND INCOMPATIBILITY**

Being awarded the present scholarship does not result in any social security treatment nor evaluations for the purposes of judicial or economic careers nor automatic recognitions for social security purposes.

Holders of the present scholarship are not allowed to perform any teaching activities under penalty of losing the scholarship.

Being awarded the present scholarship is incompatible with further public or private employment. In addition, the present scholarship is incompatible with rewarded and continued professional or consulting services; the scholarship holder may be authorised to carry out limited occasional activity provided that the latter does not interfere with the study and research activities to be carried out under the scholarship and provided that its emolument does not exceed the sum of 15,000.00 Euro per year.

Scholarships under the aforementioned Regulations are not to be added to any other scholarships whichever their purpose, apart from those awarded by national or foreign institutions aimed at integrating the activities by the scholarship holder with stays abroad.

## **ART. 6. - SCHOLARSHIP AMOUNT AND INSURANCE COVERAGE**

The gross amount of the scholarship, for the duration of 6 months, is equal to 9.000,00 Euro. It is subject to the legislation in force and payments will be issued in deferred monthly instalments, according to the activity carried out, following a declaration by the supervising professor responsible for the research programme reporting on the proper performance by the scholarship holder.

The University shall provide the scholarship holder with private bodily injury insurance coverage and civil liability towards third parties insurance coverage limited to the duration of the scholarship and within the framework of the training activities to be performed. The insurance premium is to be paid by the scholarship holder and it is deducted from the scholarship amount.

Scholarship holders are granted free access to all University facilities and shall carry out the study activities provided for by their scholarship on a continuous basis to be consistent with the programme prepared by the supervising professor and under their supervision. Activities may be interrupted up to thirty days per year. Any other interruption may entail losing the scholarship save as provided for by article 11 of the Regulations concerning cases for interruption.

At the end of the duration of the scholarship, the scholarship holder shall submit to the Department a report detailing the activities carried out.

## **ART. 7. - SCHOLARSHIP LOSS AND SUSPENSION**

Scholarship holders who interrupt scheduled activities in lack of justified reasons or who commit serious and repeated breaches of duty may lose the right to benefit from the scholarship for the time remaining. Those scholarship holders who, having accepted the scholarship, do not prove to have started the required activity shall lose the scholarship.

Those scholarship holders who, having started the activity, intend to withdraw shall notify both the Rector and the relevant body. This is without prejudice to the emolument to be paid from the moment the scholarship became effective to the date of withdrawn.

Scholarship holders may interrupt their activities only for those periods corresponding to maternity leave or duly justified extended sick leave, and for no longer than one year in either case. The scholarship shall not be paid for the duration of such periods of leave.

Upon resuming their activities, starting from the date on which the reason for suspension ended, the activity shall be carried out for the remaining period depending on the duration of the research project upon which the scholarship weighs.



## ART. 8. - COMPARATIVE ASSESSMENT

Applications shall be evaluated by a judging committee composed of the professor supervising the research project, who acts as President, and of two full professors appointed by the relevant Department.

Comparative assessment consists in evaluating the curriculum vitae and qualifications submitted by the applicant and in an interview aimed at verifying their eligibility to perform the required study and research activity. The Judging Committee may allocate up to 100 points to be divided as follows:

- 50 POINTS FOR QUALIFICATIONS;
- 50 POINTS FOR THE INTERVIEW.

Qualifications shall be assessed before the interview. The score allocated to each candidate shall result from the sum of the points allocated for qualifications and of the points allocated for the interview. After terminating its duties, the Committee shall list a ranking based on merit. In case of equal merit, the scholarship shall be awarded to the younger candidate.

The minutes signed by all Committee members are public.

Selection records shall be approved by Rector's decree and published on the University website.

The present selection shall not result in a declaration of eligibility.

**The interview will take place remotely on 03.21.2024 at 11:00 a.m. through virtual means.**

Disabled candidates must specify the special arrangements they need to carry out the interview, if any (as laid down in art.20 of Law no.104/1992 of 5 February 1992).

The winner shall be notified via registered mail sent to the address reported in the application form. Under penalty of losing the scholarship, the following declarations of acceptance must be sent by the winner to the Rector within and no later than ten days starting from the date of notification:

- ✓ Declaration of scholarship acceptance without reserve under the terms and conditions laid down in the call and in the University of Milan Regulations by which the scholarship holder commits to starting their activities from the first day of the month following that of the declaration of acceptance;
- ✓ Declaration that they are not employed by other public or private employers;
- ✓ Declaration that they are not being awarded other research and study scholarships or other grants for the whole duration of the present scholarship, except for those needed to fund stays abroad;
- ✓ Declaration that they are not being assigned or rendering any paid professional or consulting services on a continuous basis.

The University reserves the right to verify the truthfulness and authenticity of the declarations submitted and to run proper checks, including sample checks, on the truthfulness of the personal condition, facts and qualities self-declared by the winner(s).

Should the selected winner fail to submit the required documentation by the deadline set by the Administration, the candidate(s) following them in the ranking shall take their place. The same applies should the winner withdraw within 60 days from the date of the decree by which they were awarded the scholarship.

Together with the aforementioned self-declarations, winning candidates who earned their academic qualification abroad shall also send the Administration the official translation of their academic qualification certified by the relevant Italian diplomatic or consular authorities in the Country of residence according to the relevant legislation in force. Should candidates fail to submit the required documents by the deadline set by the Administration, they will be excluded from the selection.

As far as non-EU citizens are concerned, their scholarship shall become effective starting from the start

date of their visa for scientific research and from the actual start of their activities.

## **ART. 9 - SELECTION PROCEDURE SUPERVISOR**
