Marcela Rubio has over 10 years of experience applying quantitative research methods, both during her PhD and during two professional appointments first at the Inter-American Development Bank as a Research Assistant and consultant and at her current role at ODI as a Senior Research Officer, since January 2022. For over the last two years, she has

carried out research on two large migration projects, Aligning Migration Management and the Migration-Development Nexus (MIGNEX) and South-South Migration for Development and Equality (MIDEQ), the former funded by the EU's Horizon 2020 Research and Innovation Programme. As part of these projects, she has led the management and harmonization of the survey datasets and has co-authored several research pieces on the links between development, equality and migration aspirations and decision-making. More recently, she has been working on another EU-funded project, Global Strategy for Skills, Migration and Development (GS4S) where she will co-lead the survey data collection in three countries which involves defining the survey instrument, identifying target population, sampling strategy, harmonizing survey dataset, and developing research pieces.
