
I have published widely in the above fields, including both articles in peer-reviewed journals (such as the *Journal of Economic Behavior & Organization*, the *Cambridge Journal of Economics*, the *Journal of Policy Modeling*, and *Socio-Economic Planning Sciences*) and chapters in books. I am also co-investigator, work-package coordinator and leader of the Leeds University unit for the 3.6M EUR EU-funded project *A JJust Transition to the Circular Economy* (JUST2CE). The kick-off meeting will take place on September 2021.

Although my research has been mainly focused on broadly-defined macroeconomic topics, I have led modules in almost every field of economics, including microeconomics, theory of the firm, international economics, history of economic thought, and public economics. Besides, I am quite keen on quantitative methods, especially on formal modeling, introductory time-series econometrics and coding.
