All three members of the Commission were impressed by the overall quality of the materials submitted in support of this publication. Despite extensive clinical commitments, Dr dell'Osso has a lengthy list of original research and other publications in peer-reviewed scientific journals, many of which are in journals with high impact and which are becoming highly cited. These publications attest to his broad range of interests and accumulating expertise (including underlying biological and psychological mechanisms, epidemiology and psychopathology, treatment development and evaluation, and mental health service delivery). Dr dell'Osso has a track record of partnership in successful applications for research funding at the international level. The Commission members were also struck by the clear and consistent evidence of the careful mentoring of early stage researchers, so ensuring continuing excellence in Milanese psychiatry research; and by the extensive national and international collaborations which Dr dell'Osso has fostered over many years. We were also impressed by the extensive contributions to undergraduate education and postgraduate training Dr dell'Osso has rightfully embraced, his contribution to public health education through publication of a popular open-access electronic book, and his many leadership and managerial roles, through which he will have raised the profile of psychiatry education and research within the Faculty and University.
