Milan is a city in [northern Italy](#), capital of [Lombardy](#), and the [second-most populous city proper in Italy](#) after [Rome](#). The city proper has a population of about 1.4 million, while its [metropolitan city](#) has

3.26 million inhabitants. Its continuously built-up [urban area](#) (whose outer suburbs extend well beyond the boundaries of the administrative [metropolitan city](#) and even stretch into the nearby country of Switzerland) is the fourth largest in the EU with 5.27 million inhabitants. According to national sources, the population within the wider [Milan metropolitan area](#) (also known as Greater Milan), is estimated between 8.2 million and 12.5 million making it by far the [largest metropolitan area in Italy](#) and [one of the largest in the EU](#).

Milan has been recognized as one of the world's four [fashion capitals](#) (the others being [London](#), [New York](#), and [Paris](#)) thanks to several international events and fairs, including [Milan Fashion Week](#) and the [Milan Furniture Fair](#), which are among the world's biggest in terms of revenue, visitors and growth.

The **University of Milan**, known colloquially as **UniMi** or **Statale**, is a [public research university](#) in [Milan](#), Italy. It is one of the largest universities in Europe, with about 60,000 students, and a permanent teaching and research staff of about 2,000.

The University of Milan has ten schools and offers 140 undergraduate and graduate degree programmes, 32 Doctoral Schools and 65+ Specialization Schools. The University's research and teaching activities have grown over the years and have received important international recognitions.

The University is the only Italian member of the [League of European Research Universities](#) (LERU), a group of twenty-one research-intensive European Universities. It consistently ranks as first university in Italy ([ARWU](#)) sharing the place with [University of Pisa](#) and [Sapienza University of Rome](#), and is also one of the best universities of Italy, both overall and in specific subject areas in other ranking systems.
