TRAINING OR RESEARCH ACTIVITY

<p>During my PhD research I have addressed the question of the structuring and maintenance of transnational ties by migrants and migrants' descendants. Drawing on more than 80 biographical interviews with Tunisian migrants and their descendants, on an extensive 12-month multi-sited fieldwork in Southern and Northern Italy and in Tunisia and on 30 semi-structured interviews with key informants, my thesis aims to advance transnational migration studies by providing new data and proposing novel analytical interpretations.</p> <p>Beyond my PhD, I have also had the opportunity to participate in the <i>Research on labour and housing insertion of refugees and asylum seekers in the context of the Vicenza tanning district</i> of the University of Venice, with Prof. Francesco Della Puppa as scientific coordinator. Hence, I acquired significant experience in qualitative research methods, interviewing migrants and migrants' descendants in different territorial contexts as well as experts and key informants, conducting fieldwork in locales of migrants' daily life, during trips to the county of origin, within migrant associations. In the context of my thesis, I also conducted extensive secondary research, retrieving statistical data and contextual literature useful to frame Tunisian presence in Italy and its major migration dynamics.</p>
