TRAINING OR RESEARCH ACTIVITY

- 1) **Dec. 1, 2022 - ongoing:** the PRELOC project is funded by the Cariplo Foundation and addresses the issue of preparedness for unexpected crises in health and agribusiness. It is carried out by the 3 research units afferent to the University of Milan Bicocca, Bologna and Pisa. The undersigned, Vanessa Turri, is part of the Research Unit working on reconstructing the preparedness of health and social systems for the covid-19 pandemic in the cities of Milan, Bologna and Parma and its consequences on health and social policies in the post-pandemic. The



Research Unit comprises researchers from the universities of Milano-Bicocca and Bologna.

The research's work consists of: analysis of international and national academic and grey literature regarding the pandemic and post-pandemic; collection of qualitative data through in-depth interviews and focus groups with social and health administration leaders, local and national policymakers, and health and national workers in Parma and Milan; analysis and systematization of data; comparison of public policies and service governance models during and after the crisis; writing and publication of reports and academic articles; participation in international conferences.

- 2) **1 February 2022 - 31 December 2023:** member of the international evaluation team of the community project "Empowering Migrants to Be Representative Actors in Community Engagement"-EMBRACE, managed in Italy by Refugees Welcome Italy Onlus. The project is carried out in 8 EU Member States and aims to experiment with paths of co-design of local policies between migrants and local politicians. The undersigned, Vanessa Turri has the task of collaborating with the international researchers who are part of the evaluation team in the definition of indicators and qualitative tools for evaluating the success of the project; apply these indicators to experimentation in the city of Milan by administering questionnaires, conducting in-depth interviews and focus groups with migrants and local politicians participating in the project; analysis and systematization of collected data; writing and publishing reports.
- 3) **April 1, 2022 - December 31 2022:** Collaboration with the Department of Political Science, Law and International Studies of the University of Padua to carry out "Updating and integrating the database of sub-national regulatory acts against gambling". Scientific coordinator Professor Matteo Bassoli.

The research's work consisted of: analyzing about 2500 administrative law texts regarding local Italian public policies against gambling; systematizing and classifying the qualitative and quantitative data contained therein based on 27 indicators; collaborating with another researcher in the creation of the first national dataset on local policies against gambling in Italy; text analysis using NVIVO software; writing and publishing academic papers; participation in national conferences.

- 4) **October 1, 2022 - December 31, 2022:** Tutor in the course "Le Organizzazioni del Terzo Settore" held by prof. Emanuele Polizzi, at the Department of Sociology and Social Research of the University of Milan-Bicocca.
- 5) **February 1, 2021 - January 31, 2022:** Post-doc researcher within the PRIN project "Who Advises What, When and How? Policy analysis capacity and its impact on Italian policy-making" at the Department of Law of the University of Naples "Parthenope". Scientific coordinator Professor Alessandro Natalini. The project aimed to reconstruct the Policy Advice systems through the Process Tracing Methodology in four areas of national public policies: administration, health, employment, and education. The project was carried out by 4 research units composed of professionals from the University of Milan (Professor Tullia Galanti), the University of Bologna, and the Parthenope University of Naples. The undersigned, Vanessa Turri, was part of the research unit tracing the Policy Advice System of Italian administrative reforms from the 90s onwards.

The research's work consisted of: analysis of 4 public administration reform policies relating to the simplification and evaluation of public personnel; comparison of public policies and evaluation of their outcomes based on 5 indicators; creation of a dataset of contacts of first and second-level managers of the Italian public administration; administration of standardized questionnaires to managers of the Italian public administration; collection of in-depth interviews with parliamentary and ministerial protagonists of the reforms of the Italian public administration; writing academic papers; presentation at national and international conferences.

- 6) **1 September - 31 December 2021:** Tutor in the course "Management of Social Enterprises and Non-Profit Organizations" held by prof. Emanuele Polizzi, at the Department of Sociology and Social Research of the University of Milan-Bicocca.
- 7) **1 January 2017-27 November 2020:** Ph.D. research on the remunicipalisation processes of urban water services in Naples and Paris. Thesis title "Urban Remunicipalisation of Water



Services. Comparative Study of the Neapolitan and Parisian Cases." Thesis tutor: Prof. Tommaso Vitale, associate professor of Sociology at the Sciences Po University of Paris. Evaluation: Excellent with honors.

The undersigned, Vanessa Turri, reconstructed the two policy reform processes using the Process Tracing Methodology in its third variant, Explaining-Outcomes Process Tracing. Tracking the reform processes was based on qualitative data relating to the political events that took place in Naples and Paris between 2000 and 2020. The data was collected through document analysis and 19 in-depth interviews with the political and administrative protagonists of the two remunicipalisation processes. After tracking the processes, the two remunicipalisation reforms' outcomes were explained and evaluated using 5 indicators related to the quality of service: improvement in ecological sustainability, social equity, economic efficiency, transparency, and civic participation.
