TRAINING OR RESEARCH ACTIVITY

During my PhD in Political Science and Sociology, I conducted a qualitative work on the exile of Tunisian participants in the 2010-2011 revolutions, encompassing the different experiences of expatriation, forced migration and political exile. Specifically, the research delved into the intersections between the transformations of political subjectivities (memories, emotions and affects) and exile, identifying political agency within artistic and cultural productions, party politics and civil society organisations, feminist and queer solidarity networks, as well as in experiences of self-reflection and community care. To the purposes of this research, I have conducted, between the end of 2020 and the beginning of 2023, a multi-sited participatory ethnography in France (in various locations in Île-de-France and in the south of France), complemented with short-term fieldwork in Germany (two cities), Italy (two cities) and Tunis. Throughout this fieldwork, I collected 20 life-history interviews and 26 in-depth interviews with members of different associations. During the collection of life-history interviews, I have tried different approaches to help my participants recollecting their memories, always ensuring to maintain a safe environment for them. For instance, participants have shared with me objects, videos, photos, drawings, pamphlets or other material pertaining to their story that could facilitate for them the narration of their story. Furthermore, I gathered social network data of political activism in both Tunisia and in the different places of exile, and I reviewed reports from NGOs and associations concerning the Mediterranean migrations and the VISA regime. Finally, I have analysed my written data, with the support of MAXQDA, through thematic and narrative analyses.

During the PhD, as detailed in the table below, I obtained fellowships at various research centres, where I collaborated on team projects and had the chance of significantly developing my own research work. Additionally, between October 2021 and January 2022, I collaborated with the GRDR (*Migration-Citoyenneté-Development*) and the FTCR (*Fédération Tunisiens Citoyen des Deux Rives*) on a joint project aimed at mapping and studying the Tunisian diaspora in France. In particular, I was involved in disseminating the research activities and facilitating the interactive restitution of the study findings to the Tunisian communities.

Before pursuing my PhD, I equally gained empirical research experience, both in academic settings and in collaboration with associations or other institutions. Notably, during my MPhil at the University of Cambridge between 2018 and 2019, I conducted extensive ethnographic work on the memorial practices of political movements in Tunisia, with a specific focus on the "Manich Msamah" (I won't forgive) political campaign and the grassroots construction of transitional justice in post-2011 Tunisia. Furthermore, during my Bachelor, I collaborated with the Municipality of Trento, specifically the social work unit, in the collection and analysis of interviews within the Roma community of Trento. Following the guidelines of the ROMACT project, the focus of the research was on four key components (home, health, cultural identity, work) and it was aimed at enhancing the work of the social work unit within the community.

Overall, during all my fieldwork experiences, I have consistently discussed ethical practices with the research participants, I monitored and prioritized their well-being throughout the data collection process and I have often employed participatory methods in defining the primary research axes. Finally, I have always been involved in research-restitution practices, adapting them to the needs and requests of my interlocutors.
