## TRAINING OR RESEARCH ACTIVITY

<p>Throughout my doctoral research, I focused on facilitating legal and economic integration of refugees, using applied econometric methods and administrative microdata. I examined the effect of location characteristics on acquiring citizenship, the causal impacts of civic integration training on labour market outcomes, and the contributions of firm sorting to refugee-native pay disparities. Papers stemming from my thesis went through desks at prestigious journals such as the Journal of Labor Economics and presented at over ten conferences and workshops. Expanding the inequalities immigrants face, my current research investigates the uneven impacts of structural changes or extreme events on health and economic outcomes across a broader population.</p>

2020 - 2024	<b>Invisible Immigrants: Urbanisation, Co-National Density and the Legal Integration of Refugees</b> (with Cole, M., Jabbour, L., and Ozgen, C.) Exploiting the quasi-random allocation of refugees to municipalities, we investigate the influence of locational characteristics, including population density and co-national networks, on the probability of acquiring citizenship in the Netherlands. This paper is currently under review at <i>Regional Science and Urban Economics</i> .
2021 -	<b>Refugees' Economic Integration and Firms</b> (with Cole, M., Jabbour, L., and Ozgen, C.) We examine whether a civic integration component dedicated to labor market training enhances refugees' economic outcomes. This research utilises linked employer-employee administrative data for the Netherlands and employs Regression Discontinuity Design. The work is progress for submission.
2021 -	<b>UK Keyworkers - an Assessment of Pay, Precarity and Change during the Pandemic</b> (with Carmichael, F., Lewis, P., and Mogra, U.) This paper documents the varied working conditions experienced by key workers (i.e., essential workers) during the Covid-19 pandemic in the UK, using the Labour Force Survey.
2022 -	<b>Firm Sorting and the Economic Assimilation of Refugees</b> (with Cole, M., Jabbour, L., and Ozgen, C.) Using the Two-Way effect model and the Oxaca-style decomposition model, we investigate the presence of mismatches between individual abilities and firm-specific pay premiums and explore the contribution of firm sorting effects to widening refugee-native pay gaps.
2024 -	<b>Automation and Mental Health</b> (with Etheridge, B., and Ozgen, C.) This project aims to assess the relationship between exposure to automation at the firm level and the well-being of workers.
