## TRAINING OR RESEARCH ACTIVITY

In my Job Market Paper, I obtain three findings regarding the impact of the first-born child's gender on family stability. First, couples who have a first-born daughter aged 6-18 are more likely to separate than those who have a son. Second, single mothers with first-born daughters are less likely to marry. Third, couples who have a first-born daughter aged 0-5 are less likely to separate when mothers identify as Russians or Orthodox Christians. The first two findings are compatible with findings in the literature. The third one is specific to the Russian context. I use the Russia Longitudinal Monitoring Survey data for the 1994-2018 period. I estimate complementary log-log regressions of separation and partnership formation on firstborn gender, age, and a set of household socio-demographic characteristics. My findings support the conclusion that the impact of children's gender on living arrangements depends on socioeconomic conditions and thus has a different character and magnitude in different contexts.
