2020-present	Two single-authored manuscripts that will be part of my PhD dissertation and ultimately to be published. One is based on field interviews with healthcare providers and administrators on the application of Law 194 in Puglia. The other presents a new dataset on the location of abortion providers in 10 European countries and explores determinants of the distribution.
2021-present	Collaboration with Payton Gannon about the effects of Italian Law 194 on healthcare providers, resulting in three joint manuscripts: one accepted and two in review process
2020-present	Collaboration with Bruno Castanho Silva and Jens Wäckerle about gender and power in parliamentary politics using quantitative text analysis, resulting in two manuscripts (one accepted and one in progress) and an additional paper planned in the coming months
