



**Call for Applications  
for the Free Supply of Prescription Glasses  
"Stay Healthy - Goal: One Hundred Years" Project**

**Art. 1 - Introduction**

The OneSight EssilorLuxottica Foundation has sponsored the "Stay Healthy - Goal: One Hundred Years" Program, conceived and implemented by the Faculty of Medicine and Surgery together with the School of Motor Sciences at the University of Milan. The foundation has allocated 100 pairs of prescription glasses, including lenses, with an estimated value of €500—some of which have already been assigned through a previous call—for students in economically disadvantaged situations, as specified in Article 2 of this call.

**Art. 2 - Eligibility Requirements**

Only students who are regularly enrolled in a Bachelor's, Master's, or Single-Cycle Degree Program at the University of Milan and who hold a medical prescription issued by an ophthalmologist or optician within the past year, certifying the need for prescription glasses, may apply for this call.

To receive the eyeglass frames provided by the OneSight EssilorLuxottica Foundation, applicants must meet one of the following requirements:

- a) Hold a 2023 ISEE-University Certification with a declared value of €0 (ZERO);
- b) Be from one of the "particularly poor and developing countries" listed in Table A of the "Regulations on Tuition Fees, Contributions, Exemptions, and Scholarships for the 2024/2025 Academic Year" of the University of Milan;
- c) Have been officially recognized as a refugee.

**Art. 3 - Application Submission Procedures**

To apply for the selection process, candidates must send Annex A (found at the end of the call), duly completed in all its parts, to the email address [impatto.tm@unimi.it](mailto:impatto.tm@unimi.it) by March 12, 2025, with the subject line: "Application for the 'Stay Healthy - Prescription Glasses Supply' Call."

Applicants must attach a medical or optician's prescription confirming the need for glasses. The prescription will be considered valid only if issued within the past year. If the applicant does not possess the required prescription at the time of submission, it must be presented on the day of the vision assessment.

The Directorate for Innovation and Knowledge Enhancement will verify the validity of each application in accordance with the eligibility criteria outlined in Art. 2.



Failure to submit any of the required documents will result in automatic exclusion from the selection process.

Applications submitted after the deadline of March 12, 2025, will not be considered.

**Art. 4 - Notification to Beneficiaries and Vision Assessment Appointment**

Selected students will be contacted via email and requested to attend an appointment on March 17 and/or 18, 2025, at the small classrooms near the Aula Magna, located at the central campus, Via Festa del Perdono, 7. Each candidate will be assigned a specific time slot for their appointment.

During the visit, a OneSight EssilorLuxottica Foundation optician will conduct a comprehensive eye examination and coordinate the delivery of the glasses with the candidate.

If the number of eligible applicants exceeds the available spots, priority will be given to those who submitted their application earlier.
